1118 (c) (1) Annual Title I Meeting

Andrews Elementary holds an annual Schoolwide Title I meeting. All Title I parents are invited to a meeting to inform parents of Title I processes, their child's participation, and the rights of the parent's involvement.

1118 (c) (2) Flexible Meetings

Our school offers flexible options to meet with parents and schedule curriculum changes or review data, including monthly Parent Teacher Meetings. We also have parent nights to show parents teaching strategies for home and inform parents on what is being taught to Title I students in Language Arts. We have meetings before and after school; also, fall and spring Parent-Teacher Conferences are held to inform parents of student progress. Flexible activities include: Volunteers, Reading Night, Field Trips, Family Fun Day, End of the Year Celebration, Marking Period Awards, Sunrise, Grandparents and Senior Citizens Day, Tailgate Celebration, Volunteers, Fall Program.

1118 (c) (3) Program planning, reviewing, and improvements

Our school holds meetings at parent convenience to review, plan, and provide input to improve school processes. Each student reviews and signs our Parent/Student/School compact. This is also signed by the parents and reviewed at conferences. We also hold monthly Parent-Teacher Organization meetings that all Title I parents are invited to. Individual children set personal goals, graph them, and review them frequently throughout the year. These results are also sent home to parents.

We hold numerous meetings throughout the year with parents and students. These include Open House, Parent/Teacher Conferences, and Parent Nights. By progress monitoring weekly or every other week, we also share data with families on progress or concerns. Many students graph their progress and enjoy sharing their improvements with their families.

1118 (c) (4) (A) Timely Information

Andrews Elementary shares information on an ongoing basis. Through monthly Parent-Teacher Organization meetings parents are updated and given the opportunity to provide input on school processes. Parent-Teacher conferences are held twice a year, however, parents can ask to meet with teachers and administration at any time during the school year. Standards based report cards are sent home after every 9 week marking period. When appropriate, parents are informed of their child's progress monitoring and NWEA scores. On a weekly basis in class work is sent home using a home-school connection folder. School staff use planners, folders, email, websites, phone calls, and face to face communication to discuss the progress of students.

1118 (c) (4) (B) Curriculum & Assessment

At the Annual Open House parents are provided a Curriculum Guide, which outlines the grade level expectations. Student progress is updated in newsletters, planners, and through conferences. Our district Standards Based Reporting system outlines the levels of proficiency. Report cards are provided after every 9 week marking period.

1118 (c) (4) (C) Opportunities for Regular Meetings

Our school offers monthly PTO Meetings, schoolwide Internet access, phones, and weekly folders with reply sheets in them for parents to communicate to the school. We also have our Parent/Teacher Conferences, Title I Parent Night, and an end of the year parent and student survey. Our school encourages an open door policy by all of these methods.

1118 (c) (5) Ensure parents the opportunity to submit comment if not satisfied

Our school has an open door policy. If a parent has any concerns they are encouraged to meet face to face, make a phone call, email, or write a note to make us aware of their concerns. Also, a monthly Parent-Teacher Organization meeting is scheduled and communicated through our school website and on bi-weekly newsletters.

1118 (d) (A) (B) School Parent Compact Development

With the assistance of staff, students, and parents the Andrews Parent/Student/School Compact was developed to communicate the expectations of each stakeholder. The compact is discussed and reviewed by all stakeholders during the first two weeks of school. At fall Parent-Teacher Conferences teachers discuss each of the components with parents/guardians and students. It is during this time successes, challenges, and/or changes are addressed. The compact is evaluated by staff, students, and parents each year to make necessary changes.
