The following letter of agreement is between the Three Rivers Community Schools and TREA.

Due to the needed minutes counting for 1098 hours, Specials Teachers will need to cover lunches. It is agreed that those Elementary teachers who lose their planning time due to covering lunch and recess will be compensated at the following rate:

*Per the Master Agreement, Article 9 - Compensation and Benefits, 9.1.C:
Additional Teaching Pay. If a teacher agrees to accept an additional teaching assignment
schedule during his/her preparation period, such teacher shall receive additional compensation
based on:*

- 1. Middle School Teachers: One-sixth (1/6) of basic compensation*
- 2. High School Teacher: One-sixth (1/6) of basic compensation*
- 3. Elementary Teacher: One-eleventh (1/11) of basic compensation*
