Return to Learn Team

- Desire to continue remote learning in the 3rd marking period for MS and HS
  - proposed on December 7 and 14, 2020 board meetings
  - voted to remain with the plan outlined in the TRCS Roadmap at this time, will revisit as we get closer to the semester end, monitoring the St. Joseph County COVID 19 Risk Assessment
- Return to face to face instruction for elementary as soon as possible
