Reconfirmation Meeting - narrative of modifications to original Extended Learning Plan

District Comments:

Going well - class sizes for elementary, 100% face to face at elementary, student grades improving with face to face instruction, students transition well from face to face to remote, online platforms useful, seeing growth with assessments even with the number of transitions we have had (NWEA data)

Focus areas - social distancing at MS/HS, smaller class sizes across the district, clear picture of what guidelines to use for 100% face to face instruction return, use data to determine return

Proposed Guidelines - Return to 100% Face to Face

- St. Joseph County Health Department School Risk Assessment Metrics positivity rate of 7.9% or less over a 7 day period**
 - Beginning monitoring week of March 15, 2021
 - Return to 100% face to face two day following school day post receiving School Risk Assessment (i.e., Risk Assessment received on Monday, 100% F2F will resume on Wednesday

In addition to what we are currently doing:

- Universal and correct use of masks.
- Hand Washing/Sanitizing
- Cleaning and maintaining healthy facilities (air quality upgrades)
- Contact tracing in combination with isolation and quarantine, in collaboration with the health department.
- Some TRCS staff have had the COVID vaccine.

**If metrics reflect a positivity rate of 7.9% or less, social distancing will be minimized as the metrics reflect a safe return of 100% face to face instruction; will remain at 100% face to face unless we are moved to remote if an outbreak OR state order for remote learning

Public Comments:

- Board of Education approved the proposed guidelines for 100% face to face learning
- Community comments on March 1st and 15th requesting 100% face to face learning and hybrid learning. Comments submitted via Google form and face to face (3/15).

Instructional delivery method:

Pre-K-5th grade

- 100% face to face learning
- Andrews Elementary transition to 100% remote instruction February 17, 2021-February 26, 2021; return to face to face March 1, 2021

6th-8th grade

- 100% hybrid learning on January 19, 2021 February 5, 2021
- Transition to 100% face to face learning on February 8, 2021
- Transition to hybrid learning on March 1, 2021

9th-12th grade

- 100% hybrid learning on January 25, 2021 February 5, 2021
- Transition to 100% face to face learning on February 8, 2021
- Transition to hybrid learning on March 1, 2021

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations

- EL services no change from Extended Learning Plan
- Special Education and other special populations have access to in-person support and
 instruction in their home schools. Middle School and High School students who are engaged in
 hybrid instruction are offered in-person support as needed on an individual, case-by-case basis.
